Job Description: Certified Nursing Assistant (CNA) FLSA: Non-Exempt

### **General Summary:**

The Certified Nursing Assistant (CNA) performs direct personal care and provides comfort to the residents. Duties are performed in a caring, empathetic, and time-efficient manner, paying attention to maintaining the dignity of each resident and other staff members.

## **Principal Duties and Responsibilities:**

- 1. Keeps informed of changes in residents' condition.
- 2. Properly bathes and grooms residents assigned. Maintains modesty of residents during bathing. Makes certain that residents' clothing is neat and clean.
- 3. Provides services to meet each resident's physical, emotional, and spiritual needs.
- 4. Reminds residents of meals and other activities.
- 5. Demonstrates knowledge of fire and safety plans and use of safety devices.
- 6. Assists with medication management and other activities of daily living.
- 7. Transports sisters to medical and other appointments and attends appointments, as needed. Relays and records all diagnosis, recommendations, referrals, medication changes, and other pertinent information.
- 8. Takes vitals, i.e., blood pressure, temperature, blood sugar, Oxygen saturation, etc., as needed, and records data.
- 9. Records health care data and assists Healthcare Coordinator in ensuring medical records are up to date.
- 10. Participates in regular health care team meetings and communicates all health care information to the health care team.
- 11. Performs various other job tasks, as assigned by the President, the Administrator, or the Healthcare Coordinator.

#### Knowledge, Skills, and Abilities Required:

- 1. Experience and/or certification as a nurse assistant and medication management preferred.
- 2. Constant walking and standing is required. Ability to bend, stoop, reach above shoulder level, and lift up to 50 pounds.
- 3. Must be able to understand and to communicate with persons of varying degrees of dementia.

- 4. Ability to accept and cooperate with change in work and/or procedures with ease.
- 5. Ability to drive a motor vehicle and have a valid driver's license, as required.
- 6. CPR Certifications and knowledge of general first aid.

## **Working Conditions:**

- 1. Job assignments and responsibilities may vary.
- 2. Tasks assigned may involve potential and/or direct exposure to blood or body fluids. Exposure to latex, plastic, and/or materials which are used for personal protective equipment.

## **Accountability:**

The Certified Nursing Assistant is directly accountable to the Healthcare Coordinator.
